

Technical documentation to support the preparation of a declaration of conformity pursuant to Articles 5 to 12 and Article 15 of the PPWR

As your supplier, we are pleased to provide you with the information required for the technical documentation required to carry out the conformity assessment. Technical documentation within the meaning of the PPWR does not refer to technical tests or analyses. Unfortunately, as required by law, we cannot take over responsibility for carrying out the assessment procedure or issuing a declaration of conformity on your behalf. Legal responsibility for this rests solely with you.

The following information applies to all products manufactured from **fresh fiber papers** and which are **printed**. This information applies to all corrugated board packaging supplied to you by the **Panther Group**.

REACH	As a manufacturer of 'articles' under the REACH Regulation, our company is deemed a 'downstream user' and is also not subject to the REACH registration requirement. For conventional corrugated board, it can be confirmed that there are no substances from the candidate list in this product in the sense of REACH.					

4. Requirements for the recyclability of packaging pursuant to Article 6 of the PPWR	
Is the packaging recyclable?	Yes, corrugated cardboard can be classified as Class A (>95%) in terms of recyclability, provided the following conditions are met: - The corrugated cardboard consists exclusively of paper, starch, and printing inks (this applies to the Panther Group; any other components must be removed before disposal). - The corrugated cardboard is correctly disposed of in the waste paper collection. - The corrugated cardboard is collected in a sorted form without any relevant contaminants and transferred to existing industrial recycling systems.

5. Requirements for minimum recycled content in plastic packaging pursuant to Article 7 of the PPWR

Not applicable, as the packaging supplied by us is manufactured from corrugated board.

6. Requirements for bio-based raw materials in plastic packaging pursuant to Article 8 of the PPWR

Not applicable, as the packaging supplied by us is manufactured from corrugated board.

Not applicable, as the packaging supplied by us is manufactured from corrugated board and has no direct link to bio-waste, given that corrugated board packaging is generally returned to the material cycle.

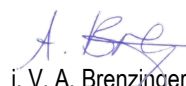
